NEW NUMBER OF SHARES AND VOTES IN KAPPAHL AB (PUBL)

On 5 December 2017, the Annual General Meeting in KappAhl AB (publ) (the "Company") resolved on an automatic share redemption procedure, which included a share split (2:1) whereby one (1) existing share in the Company was divided into two (2) shares. As a result of the share split, the number of shares in the Company was increased by 76,820,380 shares to a total of 153,640,760 shares in January 2018.

As of 31 January 2018, the number of shares and votes in the Company amounts to 153,640,760. The number of shares and votes will be restored to its original levels after the automatic share redemption procedure has been completed in the beginning of February 2018.
